CAMPING: Prohibited in the park and within USFWS Refuge Lands.

ALCOHOL: Prohibited within parking lots and launch ramp.

Permittee understands that approval of this permit is contingent on compliance with these rules, regulation and conditions. Permittee understands that Park Rangers may revoke this permit for any non-compliance WITH NO REFUND OF FEES. In consideration for being permitted by the County to use County Parks facilities, I hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which I, my guests, invitees or other third parties may have or which may hereafter accrue as a result of my use of County Parks facilities. This release is intended to discharge in advance the County (its officers, employees, and agents) from and against any and all liability arising out of or connected in any way with my use of County Parks facilities.
