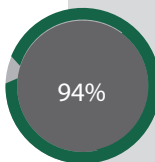
### RECAP: PUBLIC INPUT MEETING #1

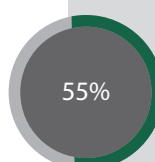

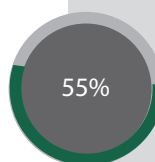
### YOUR SURVEY RESULTS
